October highlights

• \$202k revenues

• \$186k expenses

• Fund 024 balance: \$1.77 million – an increase of \$16,000 from September.

Biennium to date highlights

- Revenues:
 - o \$2.78 million from July 2023 to October 2024
- Expenses:
 - \$2.56 million in expense from July 2023 to Oct 2024. This is a \$535k underspend against allotments year to date. Underspend largely composed of:
 - Salaries/benefits: \$55k less than planned BTD
 - CA Dainis/Vorsite: \$25k less than planned BTD
 - EM Attorney General: \$73k less than planned BTD
 - ER Other contracts: \$113k less than planned BTD
 - EY Software: \$134k less than planned BTD
- Fund balance:
 - Current balance is \$1.77 million, an increase from BI25 beginning balance of \$1.54 million.

Projected BI25 end highlights

- Revenue projected to reach \$4.27 million by June 2025. BI23 ended at \$4.32 million.
- Expenses projected to reach \$4.12 million.
- Fund 024 balance of \$1.69 million. This is an increase from the BI25 starting balance of \$1.54 million.

Changes from last month

 September and October revenues were higher than average. Incorporating this data into forward looking projections results in biennial revenue projections increasing from \$4.14 million to \$4.27 million.

Analysis of Revenue Trends and Fee Increase Considerations

- Current biennium:
 - September revenues came in at \$222,810. This was much higher than the biennium to date average of \$168,631 per month (or \$4,047,144 per biennium).
 - October revenues came in at \$202,375. Again, higher than biennium to date averages.
 - Incorporating the September and October actual revenues into forward looking projections increased the:
 - BTD Monthly average to \$173,814 (before fee increases)
 - BI25 projection to \$4,171,536 (before fee increases)
 - BI25 projection to \$4,265,395 (if 10% fee increase goes live January 1, 2025)
- Long term & future biennium:
 - Initial estimates and models assumed \$4.0 million as the baseline revenue. When a 10% fee increase was applied to this baseline the resulting in biennial revenue was estimated at approximately \$4.36 million.
 - o If a 10% fee increase is applied to most current BI25 revenue projection of \$4,171,536; then future biennial revenue projects to approximately \$4.54 million.
 - Expenses are assumed to reach \$4.5 million approximately during the biennium ending June 2031.
 - o If the above assumptions hold true, fund balance may increase for a longer duration and to a higher level than anticipated in the initial fee analysis models and projections.

Hi everyone.

On the next committee agenda is a discussion about the concise explanatory statement for making pronouns gender neutral throughout various WACs. This rulemaking originally started out as expedited rulemaking (CR105), but because of the objections received, a CR102 was filed, and a public hearing was held on November 20th. There were 2 individuals that attended the hearing, and one provided comment. Written comments were also received (see attached).

I'm not sure what the Committee will recommend to the Board based on those comments. I have drafted a concise explanatory statement but have not finished the responses to the comments. (see attached). Any additional response language will be appreciated.

I'm also sending you the language that shows the changes to pronouns. If you have any comments/edits, we can discuss it at the meeting.

At the committee meeting, you can do one of the following:

- Make no changes to the language and leave it as it currently is published.
- Make some changes to the proposed language, and recommend staff file a CR103. (those changes will be addressed on the concise explanatory statement)
- Adopt the language as amended, and recommend staff file the CR103.

Washington Administrative Code Notice of Permanent Rules for WAC 196-09, 196-23, 196-33-400, 196-34-115

The Administrative Procedure Act (RCW 34.05.325(6)) requires agencies to complete a concise explanatory statement before filing adopted rules with the Code Reviser's Office. This statement must be provided to anyone who gave comments about the proposed rulemaking.

The Board received a petition for expedited rulemaking to update pronouns in various WACs. A CR105 (Expedited Rulemaking form) was filed, and parties notified. Objections to the use of expedited rulemaking and amending the language were received. A CR102 (Proposed Rulemaking form) was filed and a public hearing was held on November 20, 2024.

Adoption of: WAC 196-09 Board practices and procedures.

WAC 196-23 Stamping and seals. WAC 196-33-400 Seals and stamps. WAC 196-34-115 Qualifying activities.

Effective date: These rule changes will become effective 31 days after filing (approximately January 18, 2025).

Summary of public comments received on this proposal and the agency's response to those comments:

I disagree that this change is grammatically correct and believe it will create much confusion regarding who is professionally responsible for engineering work. As an example WAC 196-23-010 is clearly intended to address an individual's use of engineering seals and requires a specific individual to maintain control of his or her seal. To change this language to "they, them, themselves" implies there is more than just one individual who is responsible for maintaining control of seals, which is clearly not the intent of the board.

This amendment diminishes individual responsibility. "They" is easily confused with a group responsibility rather than an individual's responsibility. The law needs to be clear, and individuals have a right to be identified in the law.

The proposed language is confusing and entirely unnecessary. The language can certainly be revised to avoid confusing the singular with the plural if the board so chooses.

I recognize that BRPELS is attempting to mainstream the pronouns from he/she and her/him, but there are better ways to do so. The easiest of which is simply rewriting the sentences such that the pronouns are replaced with "the individual or entity" or "requestor" as appropriate.

WAC 196-09-130 Board member limitations—Contract selection.

- (1) When a member of the board of registration for professional engineers and land surveyors (board) is beneficially interested, directly or indirectly, in a contract, sale, lease, purchase or grant that may be made by, through, or is under the supervision of the board in whole or in part, or when the member accepts, directly or indirectly, any compensation, gratuity, or reward from any other person beneficially interested in such contract, sale, lease, purchase or grant, the member must:
- (a) Exclude ((him or herself)) themselves from the board discussion regarding the specific contract, sale, lease, purchase or grant;
- (b) Exclude ((him or herself)) themselves from the board vote on the specific contract, sale, lease, purchase or grant; and
- (c) Refrain from attempting to influence the remaining board members in their discussion and vote regarding the specific contract, sale, lease, purchase or grant.

(2) The prohibition against discussion set forth in sections (a) and (c) may not prohibit the member of the board from using ((his or her)) their general expertise to educate and provide general information on the subject area to the other members. - WAC 196-09-131 Board member limitations—Board actions. (1) When a member of the board of registration for professional engineers and land surveyors (Board) either owns a beneficial interest in or is an officer, agent, employee or member of an entity or individual, which is subject to a board action, the member must:
- (a) Recuse ((him or herself)) themselves from the board discussion regarding the specific action;
- (b) Recuse ((him or herself)) themselves from the board vote on the specific action; and

- (c) Refrain from attempting to influence the remaining board members in their discussion and vote regarding the specific action.
- (2) The prohibition against discussion and voting set forth in sections (a) and (c) may not prohibit the member of the board from using ((his or her)) their general expertise to educate and provide general information on the subject area to the other members.
 - (3) "Board action" may include any of the following:
 - (a) An investigation or adjudicative proceeding;
 - (b) Application or submission;
- (c) Request for a ruling or other determination decision, finding, ruling, or order; or
- (d) Monetary grant, payment, or award. [Statutory Authority: RCW 18.43.035. WSR 21-22-092, § 196-09-131, filed 11/2/21, effective 12/3/21; WSR 06-22-032, § 196-09-131, filed 10/25/06, effective 11/25/06.]

WAC 196-09-135 Reporting of board member recusal. If exclusion or recusal occurs pursuant to WAC 196-09-130 or 196-09-131, the member of the board should disclose to the public the reasons for ((his or her)) their exclusion or recusal from any board action whenever it occurs. The board staff should record each instance of exclusion or recusal and the basis for it in the minutes of the board meetings. [Statutory Authority: RCW 18.43.035. WSR 21-22-092, § 196-09-135, filed 11/2/21, effective 12/3/21; WSR 06-22-032, § 196-09-135, filed 10/25/06, effective 11/25/06.]

AMENDATORY SECTION (Amending WSR 21-22-092, filed 11/2/21, effective 12/3/21)

WAC 196-09-150 Public records. All public records of the board are available for public inspection and copying pursuant to these rules and applicable state law (chapter 42.56 RCW), as follows:

(1) Inspection of records. Public records are available for inspection and copying during normal business hours of the office of the Washington state board of registration for professional engineers and land surveyors. Records may be inspected at the board's office when the requestor has been notified of the availability of the requested documents and an appointment is made with the public records officer.

- (2) Records index. An index of public records, consisting of the retention schedules applicable to those records, is available to members of the public at the board's office.
- (3) Organization of records. The board maintains its records in a reasonably organized manner. The board will take reasonable actions to protect records from damage and disorganization. A requestor shall not take original records from the board's office. A variety of records are also available on the board's website at https://brpels.wa.gov/. Requestors are encouraged to view the documents available on the website prior to submitting a public records request.
 - (4) Making a request for public records.
- (a) Any person wishing to inspect or obtain copies of public records should make the request using the board's public records request form available on the board's website or in writing by letter or email addressed to the public records officer. Written request must include the following information:
 - (i) Date of the request.
 - (ii) Name of the requestor.
- (iii) Address of the requestor and other contact information, including telephone number and any email addresses.

- (iv) Clear identification of the public records requested to permit the public records officer or designee to identify and locate the records.
- (b) The public records officer may also accept requests for public records by telephone or in person. If the public records officer or designee accepts an oral or telephone request, ((he or she)) they will confirm receipt of the request and the details of the records requested, in writing, to the requestor.
- (c) If the requests received in (a) or (b) of this subsection are not sufficiently clear to permit the public records officer to identify the specific records requested, the public records officer will request clarification from the requestor in writing.
- (d) If the requestor wishes to have copies of the records made instead of simply inspecting them, ((he or she)) they should make that preference clear in the request. Copies will be made by the board's public records officer or designee.
- (e) When fulfilling public records requests, the board will perform its public records responsibilities in the most expeditious manner consistent with the board's need to fulfill its other essential functions.

- (f) By law, certain records and/or specific content of any specific record or document may not be subject to public disclosure. Accordingly, a reasonable time period may occur between the date of the request and the ability of the public records officer to identify, locate, retrieve, remove content not subject to disclosure, prepare a redaction log that includes the specific exemption, a brief explanation of how the exemption applies to the records or portion of the records being withheld, and produce the records for inspection and/or copying. The requestor will be kept informed of the expected delivery timetable.
- (g) If the request includes a large number of records, the production of the records for the requestor may occur in installments. The requestor will be informed, in writing, of the board's anticipated installment delivery timetable.
- (h) In certain instances, the board may notify affected third parties to whom the record relates. This notice allows the affected third party to seek an injunction within ((fifteen)) 15 days from the date of the written notice. The notice further provides that release of the records to the requestor will be honored unless timely injunctive relief is obtained by the affected third party on or before the end of the ((fifteen)) 15-day period.

(i) Requests for lists of credentialed individuals by educational organizations and professional associations: In order to obtain a list of individuals under the provisions of RCW 42.56.070(8), educational organizations and professional associations must provide sufficient information to satisfy the board that the requested list of individuals is primarily for educational and professionally related uses.

WAC 196-23-010 Seals. All individuals licensed in accordance with chapter 18.43 RCW must utilize a seal/stamp that conforms to the design as authorized by the board. It is the responsibility of the licensee to maintain control over the use of ((his/her)) their stamp/seal. The impression or image of the seal/stamp must conform to the below-illustrated design and be of a size that assures full legibility of the following required information:

- (1) State of Washington;
- (2) Registered professional engineer or registered professional land surveyor;
 - (3) Certificate number;
 - (4) Licensee's name as shown on wall certificate.



wac 196-23-040 Use of the title S.E. Only professional engineers who have completed the state of Washington's requirements for licensure in structural engineering are permitted to use the title of S.E. when representing ((his or her)) their licensing credentials, as in, James Smith, P.E., S.E. Use of the title S.E. by any individual who is not licensed in structural engineering as provided in chapter 18.43 RCW, is subject to disciplinary action by the board in accordance with chapter 18.43 RCW and/or chapter 18.235 RCW. [Statutory Authority: RCW 18.43.035. WSR 06-22-035, § 196-23-040, filed 10/25/06, effective 11/25/06.]

AMENDATORY SECTION (Amending WSR 18-22-076, filed 11/2/18, effective 12/3/18)

WAC 196-33-400 Seals and stamps. All individuals licensed in accordance with chapter 18.210 RCW shall procure a seal/stamp that conforms to the design as authorized by the board. It is the responsibility of the licensee to maintain control over the use of ((his/her)) their stamp/seal. The impression or image of the seal/stamp shall conform to the below-illustrated design and be of a size that assures full legibility of the following required information:

- (1) State of Washington;
- (2) Licensed on-site wastewater treatment system designer;
- (3) License number;
- (4) Licensee's name as shown on license.

WAC 196-34-115 Qualifying activities. The board believes that designers under provisions of chapter 18.210 RCW should have the discretion to make independent choices on what activities help them to be improved practitioners. The board will not provide advance approvals for selected activities or vendors. The board expects designers to seek out qualifying activities that can be demonstrated to the board as relevant to ((his or her)) their professional development as a designer.
