This document provides information regarding proposed amendments to Chapter 18.43 *Engineers and Land Surveyors* that the Board intends to submit to the Legislature during the 2026 Legislative session.

## About the Proposed Legislation document

The Proposed Legislation document for submittal to the 2026 Legislative Session is a combination of proposed amendments from last year and this year. The recent proposed amendments were approved by the Board at the June 17, 2025 Annual Board Meeting.

The Proposed Legislation document does not include all sections of Chapter 18.43, because there are no proposed amendments to them.
